### SB62 | BONN CLIMATE CHANGE CONFERENCE 2025

## Lima Work Programme on Gender



#### **Background**

Women and girls are disproportionately impacted by climate change, especially in Indigenous, frontline, and low-income communities. Despite this, they are often excluded from decision-making processes and overlooked as key recipients of climate finance. The Enhanced Lima Work Programme on Gender (LWPG) and its Gender Action Plan (GAP) work to address this by integrating gender equality into all aspects of climate policy and action, providing clear guidance for countries to put this into practice.

#### **SB62 Outcomes**

At COP29 in Baku, Parties reviewed progress under the existing Gender Action Plan (GAP) and debated whether the LWPG should be extended. There was considerable disagreement on the extent to which gender should be integrated in climate policy, which ultimately delayed a final GAP update. A key outcome was the decision to extend the LWPG for another 10 years, until 2035. Parties agreed to develop a new GAP at COP30, with initial design discussions beginning at SB62. Countries were also encouraged to strengthen national gender and climate focal points.

### What happened at SB62

#### **Technical Workshop (16, 18, 19 June)**

Participants discussed past progress, identified gaps, and designed new activities, responsibilities, and timelines for the GAP. Interactive group work refined proposals, with emphasis on intersectionality and local realities. A draft text was released for informal consultations.

#### Informal Consultations (20 - 25 June)

Parties debated key elements: structure, outputs, monitoring, and gender-responsive climate finance. Sensitive topics like care work, environmental defenders, and sexual and reproductive health and rights were discussed. The final session on 25 June confirmed the current draft as the basis for COP30, with a commitment to hold a technical workshop to consolidate the text.

#### The Road Ahead

In the lead-up to COP30, Parties will refine the draft **Gender Action Plan (GAP)** through additional informal consultations and technical workshops, potentially during regional climate events. The next formal round of negotiations will be at SB 63 in November 2025, aiming to reach consensus and adopt the new GAP. Countries are also expected to strengthen national gender focal points, secure adequate funding for implementation, and integrate gender equality as a cross-cutting issue in climate policies. This builds on the enhanced Lima Work Programme on Gender, which was extended for another 10 years (Decision 7/CP.29).
